#### PREVENTION

#### 4 - FIRST AID MEASURES

#### IN AN EMERGENCY CALL AN AMBULANCE (111).

Primary routes of exposure by inhalation of vapour and contact with skin or eyes.

#### MAIN SYMPTOMS CAUSED BY EXPOSURE

Exposure may cause allergic reactions to skin in some people.

Inhalation may cause difficulty in breathing.

#### **SWALLOWED**

Rinse mouth and drink large quantity of water. Do NOT induce vomiting.

Prevent, by any means available, spillage from entering drains or water course. Use firefighting procedures suitable for surrounding area.

#### **SPECIFIC HAZARDS**

#### MINOR SPILLS
